為使周年業主大會能按時通過各事項，會議過程將嚴守會議議程進行。

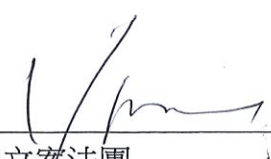
屆時各出席業主請帶同身份證明文件或公司授權書及蓋章出席，或以授權書委派代表出席為荷。
