經與管委會商討及審視屋苑現時的財政儲備及合約支出增加後,為維持屋苑財政穩健的需要,建議由 2025 年 5 月 1 日起分別上調住宅及停車場管理費 7.9%及9.5%。調整後,第 2 座恆常基金年度赤字約為\$10,979,而累積盈餘約為\$159,177。

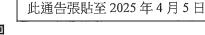

Consultation for Year 2025 Management Budget

In accordance with the requirements of the Building Management Ordinance, Management Services Office has prepared the management budget for Year 2025 and submitted it to the Management Committee, and now displayed at the lobbies for consultations.

Considering both the contract and electricity expenses being 70% of the total expenditure, the expenditure budget for Year 2025 was adjusted by referring those expenses, which were listed as below:

After discussions with the Management Committee and reviewing the current financial reserves and the increment in contract expenditures, the management fee of residential part and carpark will be adjusted by 7.9% and 9.5% accordingly with effective from May, 2025. After the adjustment, the annual deficit of the general fund will be approximately \$10,979, while the accumulated surplus of will be approximately \$159,177.
